Mine Hill residents attended the Board meeting to discuss the settlement agreement between Mine Hill Township BOE and the Dover Board of Education. Some residents were concerned and asked why both 7th and 8th grade would be pulled out at the same time and no phase in would be implemented. Mine Hill Township BOE has always recommended phase in for the amendment of the 7th and 8th grade shared services agreement with Dover Board of Education. Agreement will be sent to the Judge for approval and then it will be sent to the Commissioner of Education for approval. Residents will have 20 days once received by the Commissioner to address any concerns and recommendations.

- **a.** RESOLVED, that the Board of Education accepts the recommendation of the Business Administrator and approves the **payment of bills** from the General Operating Account, in the amount of \$530,430.02.
- **b.** This Agreement is entered into this 18th day of December, 2017 between the Mine Hill Township Board of Education, with administrative offices located at 42 Canfield Avenue, Mine Hill, New Jersey 07803 ("Mine Hill") and the Dover Board of Education, with administrative offices located at 100 Grace Street, Dover, New Jersey 07801 ("Dover").

WHEREAS, on or about March 28, 2017, Mine Hill filed a Petition of Appeal with the Commissioner of Education, captioned <u>I/M/O Application for Approval of the Modification of the Sending/Receiving Relationship Between the Mine Hill and Dover Boards of Education; Morris County</u>, Agency Ref. No. 60-3/17, seeking a limited severance of its send/receive relationship with Dover, such that Mine Hill's seventh and eighth grade pupils would return to Mine Hill to be educated; and

WHEREAS, on April 17, 2017, Dover filed an Answer to Mine Hill's Petition of Appeal, opposing Mine Hill's application; and

WHEREAS, Mine Hill and Dover desire to resolve and settle this matter pursuant to the terms and conditions set forth in this Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth in this Agreement, the Parties agree as follows:

- 1. Mine Hill will educate its seventh and eighth grade pupils in Mine Hill at the Canfield Avenue School commencing in the 2018-19 school year.
- 2. If Mine Hill cannot or chooses not to educate its seventh and eighth grade pupils in Mine Hill for any of the next five (5) school years commencing with the 2018-19 school year, Mine Hill and Dover agree that the students will be educated at Dover Middle School.
- 3. Mine Hill agrees that it will only accept choice students in grades K-6 for the 2018-19 and 2019-20 school years. However, any current choice students attending school in Mine Hill will be permitted to continue their education in Mine Hill through eighth grade.
- 4. Any current Mine Hill seventh grade students who participate in interscholastic sports at Dover Middle School will be permitted to participate in said sports for the eighth grade at Dover Middle School.
- 5. For the purposes of this settlement agreement only, both parties agree that the statutory criteria for limited severance of the send/receive relationship at the seventh and eighth grade levels are satisfied.

- 6. A committee consisting of three (3) board members each from Mine Hill and Dover shall meet no less than two (2) times per year to evaluate the terms and conditions of the send/receive contract and compile an ongoing list of proposed modifications which will comprise the negotiations process one (1) year prior to the expiration of the send/receive contract.
- 7. This Agreement is subject to the approval of both Mine Hill and Dover and the signatories to this agreement agree to recommend approval of same to their respective Boards.
- 8. This Agreement is also subject to formal approval by the New Jersey Commissioner of Education.
- 9. Once approved by the Commissioner, Mine Hill agrees to withdraw its Petition of Appeal in this matter.
- 10. Upon approval of the limited severance by the Commissioner, the parties shall immediately commence negotiations for a successor send/receive contract.
- c. WHEREAS, on or about March 28, 2017, the Mine Hill Board of Education ("Mine Hill") filed a Petition of Appeal with the Commissioner of Education, captioned <u>I/M/O</u> Application for Approval of the Modification of the Sending/Receiving Relationship Between the Mine Hill and Dover Boards of Education; Morris County, Agency Ref. No. 60-3/17, seeking a limited severance of its send/receive relationship with the Dover Board of Education ("Dover"), such that Mine Hill's seventh and eighth grade pupils would return to Mine Hill to be educated; and

WHEREAS, on April 17, 2017, Dover filed an Answer to Mine Hill's Petition of Appeal, opposing Mine Hill's application; and

WHEREAS, on December 6, 2017, the parties appeared in Court and reached a settlement of this matter subject to the terms of a settlement agreement which is incorporated by reference into the minutes of this meeting, as well as formal Board approval;

NOW, THEREFORE, BE IT RESOLVED, that the Board approves the settlement agreement in the matter captioned above in accordance with the terms and conditions therein; and

BE IT FURTHER RESOLVED, that the Superintendent is authorized to execute the agreement on behalf of the Board.

d. WHEREAS, EACM Corp. has submitted a change order No. GC-01 to furnish & install (5) five new circuits for the unit vents and add a condensate receptacle at each unit vent as requested by the Township electrical code official in the amount of \$12,220.00 using part of the \$40,000.00 allowance with a balance of \$27,780.00;

WHEREAS, Di Cara Rubino Architects has reviewed the change order and recommends approval;

NOW, THREFORE BE IT RESOLVED, that the Mine Hill Board of Education approves change order No. GC-01.

e. WHEREAS, EACM Corp. has submitted a change order No. GC-02 to credit the owner in the amount of \$2,256.03 for expenses incurred by the Mine Hill Board of Education. The credit is for custodial overtime, owner's boiler company had to drain the boilers due to a leak in a pipe damaged while EACM was performing demolition. WHEREAS, Di Cara Rubino Architects has reviewed the change order and recommends approval;

NOW, THREFORE BE IT RESOLVED, that the Mine Hill Board of Education approves change order No. GC-02.

f. WHEREAS, this agreement is made as of the 18th day of December, 2017, between the Mine Hill Township Board of Education (hereinafter the "Board" or "District") located at 42 Canfield Avenue, Mine Hill, New Jersey 07803 and the Mine Hill Educational Foundation ("the Foundation") located at 3 Indian Falls Road, Mine Hill, New Jersey 07803.

WHEREAS, the Board and the Foundation are parties to a Facility Use Agreement ("Agreement") dated March 31, 2017; and

WHEREAS, the parties wish to clarify the Agreement regarding the operating days/hours of the before and after school care program known as Canfield Kids (hereinafter "the Program") through this contract amendment,

WHEREAS, Article 27 of the Agreement provides that it cannot be modified except by written agreement signed by the parties; and

NOW, THEREFORE, in consideration of the mutual promises contained herein, the adequacy of which is hereby acknowledged, the parties agree to amend the Agreement as follows:

- 1. The Program will only run when the Canfield Avenue School is open and Canfield Avenue students are in attendance for regular educational instruction. If school is closed for the Canfield Avenue students, the program will not operate on the day(s) in question.
- 2. If there is an emergency closing the Program will not be permitted to operate.
- 3. During scheduled half days only, the Program will be permitted to operate until no later than 6:30 pm, unless in the Superintendent's sole discretion it would be unsafe for it to do so.

- 4. The Superintendent has the right to close the Program entirely on a particular day, or close the program early or delay the opening of the Program for any health, safety or welfare reason. The Superintendent shall provide as much notice as is reasonably possible to the Program Director, of his decision.
- 5. All other provisions of the Agreement shall remain the same.
- 6. To the extent that there are any conflicts between this amendment and the Agreement, this amendment shall control.

IN WITNESS WHEREOF, the Board and the Foundation caused this Agreement to be executed and delivered by their respective authorized representatives as of the above written date.

g. RESOLVED, that the Mine Hill Board of Education accepts the recommendation of the Superintendent to apply for a grant and accept the funds available through **Learning Ally**, an audio support program for struggling readers. The grant is a two year commitment, the first year the program is free the second year the program would cost approximately \$800.00.
